

**Here are some of the things you can do on the [myfordbenefits.com](http://myfordbenefits.com) Web site:**

- Confirm and update dependent information online
- Enroll in or change your health plan benefit coverage
- Access the **Health Plan Evaluator** tool from the home page by selecting **Health & Welfare** —> **Planning Tools** —> **Compare Plans/Calculate Costs** link to help you choose which Ford healthcare plan best meets your needs
- Ask benefits questions via the real-time **Chat** feature (select **Click to chat** under **Chat Online!** from the **Live Help** section)
- View documents, forms and helpful links while researching your health plan benefits
- Link to provider Web sites to search for healthcare providers, hospitals and labs that participate in your plan
- For the TESPHE you can:
  - Select, change or review contribution rates, beneficiaries, investment options and investment performance
  - View your statements online

## Drive Health

Beginning June 1, 2010, the new [myfordbenefits.com](http://myfordbenefits.com) Web site will allow you to view your health plan benefit information and take advantage of self-service tools.

Through the secure Web site, you have access to self-service benefit capabilities 24 hours a day, 7 days a week from home or work. This enables you to quickly and easily complete your health plan benefit transactions online throughout the year.

Each plant location has a Union Benefit Representative (UBR) that is available to assist you with questions you may have about your benefits. The UBR can help you access the [myfordbenefits.com](http://myfordbenefits.com) Web site or with contacting the NESC.

## Health Plan Enrollment:



Beginning on June 1, 2010:

- You can go to the [myfordbenefits.com](http://myfordbenefits.com) Web site for detailed information on your health plan benefits as well as Chat with a Personal Benefits Representative.
- You can also call the NESC at **1-800-248-4444**. When you call the secure service center, you will have to provide your Social Security Number (SSN) for personal identification purposes.

During the year, you may change your medical and/or dental plan elections once every 12 months.

For questions about the benefits provided by each plan, contact the health plan directly.

## Contacting the National Employee Services Center (NESC):

If you need to call the NESC with questions about your benefits, your User ID for the phone system will be your SSN. You may not use an alternative User ID for telephone access. Your PIN, however, will be the same for both the Web site and the NESC.

**Remember:** Keep your User ID and PIN confidential.
